## CCWSC WATER DEPARTMENT HIGHLIGHTS

### What's happening this month

- We received the Texas Commission on Environmental Quality (TCEQ) approval letter for construction of the 120k gallon ground water storage tank on 10/21/22.
- Gonzales Contracting, Inc. was awarded the bid for the foundation work for the 120k gallon ground water storage tank.
- We met today with G&W Engineering and Gonzales Contracting, Inc. for the Foundation Kickoff Meeting. Gonzales Contracting, Inc. will start the work on the foundation 1<sup>st</sup> week in December. We will be placing temporary fencing to protect the water plant during this time.
- Global Forge was awarded the bid for the 120k gallon ground water storage tank construction. Global Forge is manufacturing the 120k gallon ground water storage tank and expected delivery will be in February 2023.
- Mercer Controls who have been working on our Generator installed a variable-frequency drive (VFD), but we are still having issues. Mercer has recommended that we have Waukesha Pearce Industries - (WPI) come out and troubleshoot a fuel issue. They are set to come out on 11/8/22.
- We are waiting on TCEQ approval for the 5k gallon pressure tank. They will start foundation work for the tank soon. The demolition work on the 2.5k pressure tank will be done in the next few weeks.
- Robert Boone demolition and removed the old cement building in the main plant. Al's Affordable Building – Port Lavaca delivered the new portable building on 10/21/22. The building is a side lofted barn 10x16 and the cost of this building was \$6,049.79. This building was placed on an existing cement slab in the main plant. This building was purchased to house supplies regulatory records that we have to maintained in a climate control building. This will allow us to have storage space that we did not have prior.
